

TERMS AND CONDITIONS: WEDDING CONTRACT

Thank you for choosing The Fleece Countryside Inn. We respectfully ask that you read and agree our Terms & Conditions below.

Booking:

Provisional Bookings are held for 7 days, after which time they are automatically released unless a deposit is settled. We regret that all deposits/ booking fees are non-refundable or transferable in the event of any cancellations or postponements. All bookings are considered provisional until the booking contract (terms and conditions) is signed by the client. If payments are not made on time as per the below payment schedule The Fleece Countryside Inn reserves the right to cancel the booking and retain any payments made.

Payment:

- £500 booking fee (to be deducted from final balance)
- 25% of the remaining balance is due to be paid 3 months after the initial deposit was settled
- 50% of the remaining balance is due to be paid 6 months prior to the wedding date.
- 6 weeks before your wedding we require the final balance to be paid

Summer Wedding Packages

There is a minimum requirement of 80-day guests and 120 evening guests for celebrations and these will be the minimum numbers charged for even if the final numbers fall below them.

Winter Wedding & Marry Me Midweek Packages

There is a minimum requirement of 40-day guests and 80 evening guests for celebrations and these will be the minimum numbers charged for even if the final numbers fall below them.

Spring & Autumn

There is a minimum requirement of 50-day guests and 100 evening guests for celebrations and these will be the minimum numbers charged for even if the final numbers fall below them.

Nearest & Dearest

There is a minimum requirement of 25-day guests for celebrations and these will be the minimum numbers charged for even if the final numbers fall below them.

Children's Policy

Children are charged at 50% of the package price between the ages of 3 -12 years if they have half portion wedding breakfast or the children's menu. After this they are charged at the full package price. Children up to the age of 3 are free of charge.

Wedding Menu Taster

If built into your package you are entitled to a menu taster for the wedding couple or the wedding couple plus 4 additional guests. Additional guests are charged at £25pp. You will need to pre-select Two Starters, Two Mains and Two desserts to sample. You can also sample one vegetarian starter and main if required for dietary purposes. Please refer to your package details for this.

Entertainment & Decorations

All entertainment must finish by 12.00am. Any Items i.e. table plans, candles, table centres, guest books, photo frames, brought into The Fleece Countryside Inn for your special day, must be collected the morning by 11am after the event, as The Fleece cannot be held responsible for items not collected after this time.

Consumption of own beverages is not permitted on our premises unless this has previously been agreed and appropriate corkage pre paid. Failure to comply with this will result in a £50 charge to the person found with the alcohol. We may also send you promotional material via email to promote any deals or content we think you would like.

Wedding Accommodation

Where possible all 7 bedrooms will automatically be reserved for your wedding guests and will be added to your invoice (including the bridal suite). Please advise your guests all rooms will be available from 2pm on the day of arrival and must be vacated by 11am on the day of departure. 2 months before your wedding day all bedrooms need to be confirmed, any that you don't confirm will be released to the public at this time. Any rooms that are confirmed but cancelled within 2 months of your wedding day will still be charged for.

Venue Liability:

The company reserves the right to cancel any booking should they deem it necessary. The Fleece Countryside Inn shall not be liable to the client if they are prevented from carrying out any or all of its obligations by circumstances beyond its reasonable control including Government intervention, strikes, labour disputes, accidents, acts of god, national or Local disasters, war or any event causing the whole or a substantial part on the venue to be closed to the public. If your guest numbers exceed 100 you will be required to have 2 security personnel. This is to protect both our license and to ensure you have a wonderful and safe event. This will be automatically added to your invoice at the sum of £300.

The Fleece Countryside Inn highly recommends you take out Wedding Insurance for your special day.

Customers Liability:

The Customer shall be responsible for the orderly and safe conduct of the function and shall have regard to any regulations imposed by the competent authority, and shall ensure that nothing shall be done which will constitute a breach of the law or in any way cause a nuisance or be an infringement, of or occasion or render possible the forfeiture of the Licences for the sale of wine, beer, spirits, or for music and dancing or other permission attaching to the Hired premises. In particular the customer shall fully indemnify the Company against any claims, or loss or damage arising as a result of breach of the clause.

Damages

The Fleece Countryside Inn reserves the right to change or alter facilities or grounds including new development, future planning, construction, maintenance or repairs. The Client assumes responsibility for damage caused to the property, contents or grounds by them or any of their guests attending the event. Any costs incurred by The Fleece Countryside Inn will be added to the final bill and must be reimbursed to The Fleece Countryside Inn by the Client. The Fleece Countryside Inn accepts no responsibility for any damages caused to guest vehicles or belongings howsoever caused.

Cancellation

The Bride and Groom must advise The Fleece Countryside Inn on all cancellations and must forward the details in writing. In the unfortunate circumstances that you have to cancel or postpone your confirmed booking at any time prior to the event you will automatically forfeit your deposit and all monies paid in advance, or will be required to pay any amounts outstanding. Please see Payment schedule above for clarification. If a cancellation is made and payments have not been made in accordance with the payment schedule above any outstanding payments will be pursued.

2. We understand cancellation charges are applicable and will be calculated in accordance with these terms and conditions.
